Dear Member,

With reference to our letter dated 5<sup>th</sup> March, we are hereby informing you about the attempt by some individuals to mislead its meaning, arguing (more or less politely) about the qualification of "true citizen of Albarella". We would like to shortly recap the events, hoping that the issue is clear to everybody, this time:

- attorney Mariotti wrote a letter to our members on behalf of the "New Albarella Project" Committee by which he invited them to support the initiatives that the above-mentioned Committee will be promoting during the next Members' Meeting. It is self-evident that the invitation was addressed to Members, as the Members' Meeting is attended by members only;
- to support his invitation, attorney Mariotti used the following wording: "and, **like you** - member - I have a house in Albarella".

Based on the above, and for the sake of preventing our Members from being misled, our Association deemed it necessary to point out that attorney Mariotti is not one of our members. Our point was not (and it is not) a mere formality: as extensively clarified in our letter, it was (and it is) rather intended to point out that our Association shall never consider dealing with interlocutors - whether individually or in the form of committees - who are outside our Association, which, in our opinion, is a sign of respect to our members. Our previous letter was (and is) quite clear about this (we are attaching it hereto for easier consultation).

We would also like to take this occasion to talk about our new project "*Immersi nella Natura*", which will be presented on 31<sup>st</sup> March 2018 at 11 a.m. This date and time were selected long ago for the following reasons:

- the date around Easter was selected in order to offer our Members, who spend their holidays on the island, a chance to participate;

We have been informed about some of our members having received a letter signed by attorney Andrea Mariotti on behalf of the Committee of the "New Albarella Project".


If you have received the above-mentioned letter, we would like to clear all possible misunderstanding and point out the following:
